However, women's participation in professional activities must have a good purpose so that their work does not interfere with the rights of a husband and children because taking care of the Household is the right of a wife (women) (Al-Faqi, 2015). In the millennial era, as it is today, the nature of women is often associated only with being a wife and housewife. The term 3 M (masak, macak, manak) with other terms can cook, good at dressing up and giving birth (Fandilla, 2024).

As time passes, social life is increasingly developing along with rapid technological advances. This requires society to develop its resources and expertise to keep up with social changes. Many people, even women, have great opportunities to get an education to expand their knowledge and are free to choose their paths. So, this freedom provides opportunities for women to compete in getting jobs, where education, considered a label for getting a job, has made a new history in modern life. People are considered capable, able, competent, and worthy of being accepted for a job because of their high level of education (Masripah, 2022).

In addition, the era's development has also caused society's economic needs to soar. This is also influenced by the increasingly diverse needs of the Household. In this case, the husband's income as the breadwinner is required to meet the needs of the Household. However, the fact is that now, not a few women also choose to work and even have a good career in the world of work accompanied by having a degree or higher education.

Indonesia is a country with quite dense economic activities with high mobility. Even in big cities, many companies often open job vacancies on a large scale, but with certain requirements and criteria, such as minimum education, height, physical health, and so on, which sometimes many Indonesian people, especially in rural areas or in remote areas, these requirements have not been met because their human resources are still low, and their culture is still common when someone does not prioritize education up to high school or college level. This is what often causes someone to be tempted to look for work, even abroad (Arifin, 2024).

Women carry out this phenomenon on the pretext of helping the family economy meet needs so that women have a dual role, namely as career women with high degrees and as housewives.

Career Women means women with financially independent jobs, working for someone else or having a business. She is identical to smart women and modern women (Jusmaliani, 2008). In Islam, career women are women who play the role of someone who pursues a profession to meet their needs, in addition to their role as wives and homemakers, so they are often called women with dual roles (Sari & Anton, 2020).

In addition, from the perspective of society, highly educated women have a high position in their social life (Setiawati, 2017). It is undeniable that education is the main capital of someone's life. With higher education, someone will find it easier to get access to health, work, and other social life (Utomo, 2013). So what is the role of women in balancing household affairs and work and education to maintain the welfare of the Household?

In research, others wrote "The Dual Role of Career Women (The Dual Role Conflict of Career Women Reviewed in Islamic Perspective)" by Siti Ernawati in 2016. In the research, the writer concludes that factors that encourage women to pursue careers are not only driven by the economy but also by factors such as the person who appears to desire to develop and play a role in society. The rise of women in the world of careers has had a big impact on all aspects of life: good life, personal and family, and good from economic, psychological, social, and developmental aspects, as well as life in the public. However, when women enter the world of work, they have a double role, both at home or in place of work (career). In this case, girls' careers often face a conflict between family and work that is not under control and can hinder success. Women's careers operate at home as mothers and wives and in their roles in the workplace (Ermwati, 2016). The discussion focuses on the dual role of women as housewives and career women and the conflicts faced in these conditions. In Islamic teachings, women are honored creatures. Therefore, Islam highly protects women's rights, whether it is the right to obtain education or the right to obtain work and have a career. 
